Note : Eligibility conditions of the Candidates for the post of Governing Council Member:

Any good standing member can be candidate for one post only provided he/she has below mentioned qualifications (but not necessary to be the members of that electoral wing).

1. Must have completed minimum **3 (three) years regular membership** of any of the Centre of Mahavir International and must have held any **one post** of following posts for full one term of 18/30 months. :
 (i) Chairman (ii) Vice Chairman (iii) Secretary of Centre (iv) Treasurer of Centre (v) Governing/General/Regional Council Member (vi) Zone Chairman (vii) Zone Secretary (viii) Int. Vice President (ix) Int. Director (x) Int. Regional Secretary (xi) Int. Treasurer (xii) Director of Board/Office Bearer in Centre.
2. Only persons enlisted in voter list are entitled to propose & second.
3. The Election of Governing Council will be held Zone wise. The Candidate should file his nomination for the Zone where his centre exists. Nomination paper can be rejected if not filed for their respective zone.
4. The candidate may note that election will be subject to the maximum number of Governing Council members that can be elected from the respective zones is as shown in the voters lists of the Zones.
5. The voter will have only one vote, even if his/her name appears at more than one place.
6. The candidate must fill all the columns/rows. Incomplete form with cuttings/overwriting will be rejected.
7. The decision of the Election Officer shall be the final.
