Note: Eligibility conditions of the Candidate for Election for the post of International President:

Any good standing member can be candidate for one post only provided he/she has below mentioned qualifications (But not necessary to be the members of that electoral wing).

1. Must be regular member of Mahavir International for **last over 7 (Seven) years and must have held any of two posts mentioned herein each for full term of 18/30 months :**
 (i) Founder Member or present or past Int. President. (ii) Int. Vice-President or Int. Secretary General
 (iii) Int. Treasurer or Int. Director (iv) Int. Regional Secretary or Zone Chairman or Center Chairman for full term of two years each term lasting for not less than 18 months, maximum 30 months including extension period (if any).
Note : No person shall be eligible for the post of International President for more than (two) 2 terms, each term lasting for not less than 18 months, maximum 30 months including extension period if any.
 However, for holding the office of International President for 3rd term (one break essential), the candidate will require to get approval (i.e. votes) from minimum 2/3 majority of total votes casted and if not than other candidate obtaining maximum votes shall be declared as elected.
2. Only persons enlisted in voter list are entitled to propose & second.
3. The voter will have only one vote, even if his/her name appears at more than one place.
4. The candidate must fill all the columns/rows. Incomplete Form with cuttings/overwriting will be rejected.
5. **The decision of the Election Officer shall be the final.**
